Allotment Secretary's Report:

Plots

I said in the last newsletter there were a number of plots in an unsatisfactory and uncultivated condition and that with the number of people waiting for plots we cannot justify this. I am very aware that the poor weather hasn't helped as weeds have in many cases grown far faster than crops! Even so it is clear that some plots have not been cultivated for a substantial period. Some of these plot holders may indeed be considering giving up their plot, as they have not been able to continue working them. If you are not able to manage or are intending to vacate your plot, please get in touch with me as I have a number of people who are keen to begin digging ready for the spring planting season.

Footpaths

It is a matter of concern that a number of plot holders have been allowing the boundaries of their plots to extend on to the designated footpaths. In many cases this amounts to only six inches. The problem is that, particularly where there are fixed structures such as sheds and manure bays, the width of already narrow paths is restricted. In a number of cases these paths have become virtually impassable to plot holders wishing to access the manure bays with a wheelbarrow. Over the next few months the committee will be redefining many of the paths with pegs and twine. It may mean you need to reinstate footpaths and edgings or indeed move sheds/manure bays etc. In the meantime I would ask plot holders to show consideration to others by being careful not to encroach on the paths, and to recognise that in many cases crops can grow a substantial distance over paths. All fixed structures must be positioned **at least** six inches in from the path to allow for the mowing of the paths.

Cars on site

It has recently come to my attention that some plot holders are parking their cars beside their plot whilst they work. The paths are not wide enough to allow plot holders with wheelbarrows to pass a parked car. You may bring your car on to the site to drop off and collect items from your plot and then you must park it on the road.

Finally on a recent plot inspection I was favorably impressed with a number of new plot holders who had worked very hard to bring very poor plots up to a very good standard. We shall shortly be recognising these plot holders with a small prize for the most improved allotment by a newcomer.

Lets hope for a better summer next year!

Treasurer's Report

The three months since our last newsletter seem to have flown by. The financial situation of SHAS continues to improve week by week and I am now confident that the control processes we put in place after the previous treasurer resigned have enabled us to not only steady the ship, but to know how much each event or activity costs and/or contributes to the overall cash position and have put us on a sound financial footing. What a difference six months can make! With the money that we have saved on general administration costs on previous years and increased sales in the trading hut we have been able to fund several cash projects this year.

Machinery-we've spent around £450 on the maintenance, repair and in some cases replacement of lawnmowers, strimmer, hedge cutters, generators, rotavators etc. They are available for all plot holders to use and for the remainder of this year all we are asking for is a contribution towards the cost of the petrol. From January 1st next year we will be funding their running costs slightly differently-watch out for future announcements. Contact Kevin or David for details on how to get access to the machinery.

Waste-We've spent £150 on rubbish removal from the plots earlier in the summer and are finalising the arrangements with a local rubbish removal and recycling firm to work in partnership with us in the future. For a further one time this year, the society will pay for the removal of green and none green rubbish from the site. Plot holders will be able to obtain sacks from the Trading Hut to fill with green waste and place along with bulk non-green waste near the gates for collection. **PLEASE PHONE A COMMITTEE MEMBER FOR DETAILS AFTER 30th SEPTEMBER or watch out for special notices**

Security-As Don said in his article, significant amounts have been spent on changing locks and having new doors built and existing doors repaired on the trading huts and tool sheds. This was funded by the successful claim made

on the insurance policy following last years break in. There is still a surplus for further improvements.

Gala Hot Pot Evening - I have bent the Chairman's arm and he has agreed that this year the society will be subsidising the cost of the tickets for this event. Your cost is £6.50 per ticket (see Sylvia's article)

Trading Hut - I'd like to thank all the volunteers who have staffed and stocked the hut this year and put up with ever changing methods of recording sales and banking etc. The fruits of your labours can be seen by having the highest level of sales and profits for the last 5 years!

Please note:

- There are bargains still to be had with many items reduced to half price or less with some items at ridiculous give away prices.
- Existing stock lines have been reviewed and once the current stock has been sold, some will not be renewed. However, please let me or any other Committee member know if there is any item you would wish to buy but we don't stock it. If there is enough demand then we will stock those items.
- The general pricing policy has been reviewed and many items have had their price held or reduced. We will try and ensure margins are as small as possible whilst still maintaining some profit in order to benefit the society.
- Remember -this is **your** shop to cater for **your** needs. As far as possible, we will keep prices competitive but we know that sometimes we will be dearer than Wilko's or another supplier. I would encourage you to still buy from us knowing that any money we make is not wasted but invested in the society and the plots. It is your way of donating funds throughout the year.

Remaining open Sundays this year are: 19th September, October 3rd and October 17th.

David Taylor writes:

EQUIPMENT

All equipment has recently been serviced, repaired or replaced and are in excellent working order. It is important that when any machinery is used it is cleaned and left in good condition. Any defects must be reported immediately.

For safety reasons, suitable clothing must be worn at all times: i.e. long trousers, goggles and gloves when using the strimmers.

Long grass is to be cut with a rotary mower and cylinder mowers used on short grass. Strimmers are to be used on extra long grass and weeds etc.

If any abuse of the machinery is seen or reported then consideration will be given to withdrawing this facility. This equipment is expensive to purchase and maintain and we expect all users to treat it as if it were their own.

The charges for the use of the equipment is currently £1.50 for the mowers and 50p for the strimmer (extended use would require a higher donation) but as the treasurer has said, this is under review for next year.

Note: It is the responsibility of the user to take all precautions with regards to safety, as SHAS nor its elected officers does not accept any responsibility for injuries or damages sustained whilst using any of the available machinery.
